<p>What is the overall deductible?</p>	<p>\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; Network provider: \$7,500/ individual or \$15,000/ family Out-of-network provider: \$21,600/ individual or \$43,200/ family</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care and primary care services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible. If you have other family members in this plan, they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.</p>
<p>What is not included in the out-of-pocket limit?</p>	<p>Copayments for certain services, premiums, balance-billing charges, and health care this plan doesn't cover.</p>	<p>Even though you pay these expenses, they don't count toward the out-of-pocket limit.</p>
<p>Will you pay less if you use a network provider?</p>	<p>Yes. See www.mountainhealth.coop/find-a-doctor or call 1-855-447-2900 for a list of network providers.</p>	<p>This plan uses a provider network. You will pay less if you use a provider in the plan's network. You will pay the most if you use an out-of-network provider, and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Excluded Services & Other Covered Services:

Services Your [Plan](#) Generally Does NOT Cover (Check your policy or [plan](#) document for more information and a list of any other [excluded services](#).)

- Abortion - except in the case of rape, incest, or when the life of the mother is in danger
- Dental Care (Child)
- Long Term Care
- Hearing Aids

Other Covered Services (Limitations may apply to these services. This isn't a complete list. Please see your [plan](#) document.)

- Acupuncture - Up to 12 visits/year
- Bariatric Surgery - Up to 1 per lifetime, [preauthorization](#) required
- Chiropractic Care - Up to 20 visits/year
- Cosmetic surgery - Only if medically necessary for certain reconstructive surgeries
- Dental Care (Adult) - up to \$100 limit
- Infertility treatment, except artificial fertilization
- Non-emergency care when traveling outside the United States. See www.mountainhealth.coop/plan-listing for more information.
- Private-duty nursing – limited to inpatient hospitals without an ICU
- Routine eye care (Adult) - up to \$60 limit
- Routine foot care provided to a member with Diabetes
- Weight loss programs - [Preauthorization](#) required

Does this plan provide Minimum Essential Coverage? Yes

Note: These numbers assume the patient received care from an UHCP [provider](#) or with IHCP [referral](#) at a non-IHCP. If you receive care from a non-IHCP [provider](#) without a [referral](#) from an IHCP your costs may be higher.
